

Regulations of the Scientific Congress "Child Research and Education Congress"

Rzeszow, 08.02.-09.02.2024

§ 1. General Provisions:

1.1 The Scientific Congress "Child Research and Education Congress", hereinafter referred to as the Congress, will be held on 08.02.-09.02.2024 in Rzeszow (or the nearest area).

1.2 The organizer of the Conference is the Institute of Pedagogy of the University of Rzeszow.

1.3 The Congress is implemented within the framework of the project "Excellent Science - support for scientific conferences" No. DNK/SP/547893/2022.

1.4 The following terms used in these Regulations shall mean:

a. Organizer: the Institute of Pedagogy of the University of Rzeszow

b. Participant: a person whose application sent via the application form available on the website www.childresearchcongress.pl will be accepted by the Scientific Committee of Congress.

1.5 The Organizer reserves the right to make changes to the program and Regulations of the Congress and undertakes to publish updated information on the website.

1.6 The provisions of these Regulations are an integral part of the Application for participation in the Congress and apply to all Participants.

1.7 The official website of the Conference is located at: www.childresearchcongress.pl.

§ 2. Participation in the Congress:

2.1 The condition for participation in the Congress is to apply for participation in the Conference by completing the registration form available on the Conference website.

2.2 Registration requires providing personal data of the Participant, i.e. name, surname, e-mail address, academic degree, institutional affiliation, contact telephone number, form of planned participation, title of the paper, abstract, keywords, as well as expressing consent to the processing of personal data, use of image.

2.3 The Congress participant is required to:

a. send the finished article in electronic form in doc or docx format to the e-mail address:

mkinal@ur.edu.pl by 30.12.2023. The submitted articles will be subjected to the publishing procedure of the relevant editorial board, and the author(s) will be informed about the qualification of the work for printing by e-mail to the previously indicated address. The organizers reserve the right to decide on the qualification of the article for the selected journal and to reject the article that does not meet the publishing requirements.

§ 3 Consent for use of image

3.1 During the Conference the Organizer may conduct photo sessions and filming of the Conference for documentation, promotion and advertising of the Organizer.

3.2 Participation in the Congress is tantamount to expressing gratuitous, unlimited in terms of quantity, time and territory, consent to the gratuitous use, processing, reproduction and repeated

dissemination of the participant's image recorded on the photographs taken during the Congress without the need for their approval each time, for informational, promotional and advertising of the Congress. The above consent is tantamount to the fact that the photographs and recordings taken during the Congress may be posted on the Internet, including primarily on the Congress website at www.childresearchcongress.pl, as well as open, closed and social networking sites Facebook, Instagram, etc.

§ 4. Personal data:

4.1 The administrator of the Participants' personal data is the University of Rzeszow.

4.2 The Congress Organizer shall not transfer, sell or lend the collected personal data of Participants to other persons or institutions.

4.3 Personal data provided by the Participant is treated as confidential information and is used only for the purpose of communication between the Participant and the Congress Organizer.

4.4 The Participant's personal information contained in the registration form collected by the Organizer is processed in order to conduct the Congress in accordance with the provisions of the Regulations, including the creation of a list of Participants, badges and the Congress program.

4.5 By registering, the Participant agrees to the processing of his/her personal data for the purpose of conducting the Congress in accordance with the provisions of the Regulations.

4.6 The Participant's personal data shall not be transferred to other data administrators without his/her knowledge and consent.

4.7 Provision of personal data is voluntary, but necessary for participation in the Congress. Data subjects have the right to access the content of their personal data and the right to rectify, delete, limit processing, the right to data portability, the right to object, the right to withdraw consent at any time without affecting the legality of the processing carried out on the basis of consent before its withdrawal.

4.8 The Organizer shall take all appropriate security measures in accordance with the provisions of law, as well as generally accepted principles to protect the confidentiality of information.

§ 5. Final provisions:

5.1. The Organizer reserves the right to use the e-mail address provided during registration for the Congress to notify Congress Participants of, among others, changes to the Congress programme, Rules and Regulations and to send invitations to future editions of the Congress.

5.2. The Congress Participant confirms by signing the attendance list on the day of the Congress and the registration form that he/she is familiar with the Regulations and accepts their provisions.

5.3 By submitting the application form, the Congress Participant confirms that he/she agrees to the free use of his/her image, voice and statements recorded during the Congress.

5.4 Any disputes that may arise from participation in the Congress will be settled by a court of competent for the Organiser's seat.

5.5 In matters not covered by these Regulations, the provisions of the Civil Code shall apply.

5.6 These Regulations shall enter into force on 25.03.2023.
